NOTICE OF SUSPENSION



Pursuant to Article 44, Clause 4 of the Teacher Trainees' Association of Ghana (TTAG) Constitution as reviewed, the National Executive Council (NEC) hereby notifies you of your suspension from the position of Sector President for a period of three (3) months, effective 1st September, 2024 subject to review.



For the avoidance of doubt, the suspension is based on the following grounds:



1. Your unilateral action in writing a letter to the Speaker of Parliament without the requisite knowledge and approval of the Sector Executive Council (SEC) of ATTRICONS, the National Executive Council and the National Secretariat of TTAG. This action constitutes a clear violation of Article 17, Clause 4 of the TTAG constitution. Which is also a clear case of Article 44, clause 2(a) and (b) of same document.



2. Your unilateral action has brought considerable ridicule to the Association's image and its leadership from among its membership and the general public, which is a clear situation of Article 44, Clause 2(e) and (f).



3. Your unilateral action cast concerns of doubt on the effectiveness, commitment and integrity of the ability of the Sector Executive Council members, Sector Executive Officers, National Executive Council members, National Secretariats and the entire leadership structure of the Association.



By this notice, you are required to:

- Hand over all the Association's assets to the Sector Coordinator within seventy-two (72) hours.
- Relinquish all duties and responsibilities as Sector the President during the suspension period.
